erecting, furnishing, and equipping a new elementary school building; erecting, furnishing and equipping additions to school buildings; remodeling, equipping and re-equipping, and furnishing and refurbishing school buildings; acquiring, installing, equipping or re-equipping school buildings for instructional technology; purchasing school buses; and acquiring, preparing, erecting, developing, improving, and equipping playgrounds, play fields, athletic fields and facilities, and sites?
